CORRECTION ORDER

WHEREAS the Commission being satisfied that an error of transposition (\$356.20 instead of \$365.20) occurred in the Order giving effect to the Commission's decision of 21 July 1999 (T8413 and T8483 of 1999) varying the **BUILDING TRADES AWARD**; and

WHEREAS The Australian Workers' Union, Tasmania Branch, the Construction, Forestry, Mining and Energy Union, Tasmanian Branch and the Retail Traders Association of Tasmania consent to the Commission correcting Order No 1 of 1999; and

WHEREAS the Tasmanian Chamber of Commerce and Industry Limited and the Tasmanian Sawmillers Industrial Association consent to the Commission correcting Order No 1 of 1999, but object to that Order being retrospective in operation on the grounds that there are no special circumstances for giving retrospective effect to the Order; and

WHEREAS the Commission, having heard the employers' objections, has formed the opinion that the need to correct a demonstrable error so that the award accurately reflects the decision of the Full Bench of the Commission in matters T8413 and T8483 of 1999 comprises special circumstances that make it fair and right to make such an Order retrospective;

THE COMMISSION, in accordance with Section 19(2)(a) of the *Act*, hereby corrects Order No. 1 of 1999 by deleting the following classifications and wage rates from Clause 8 - Wage Rates for Employees in Division A, paragraph (b) - Weekly Wage Rate:
