AMEND THE **SHELLFISH INDUSTRY AWARD** IN THE FOLLOWING MANNER:

1. Delete Clause 8 - WAGE RATES, and insert in lieu thereof the following:

8. WAGE RATES

1. WAGES - ADULTS

(a) Adult employees in a classification level undermentioned shall be paid the weekly wage rate appearing opposite that classification.

Shellfish Farm Attendant (as defined) Level 4	100%	417.20	16.00	433.20

2. JUNIORS

A junior employee (as defined) shall be paid the undermentioned percentage of the weekly wage rate for a Shellfish Farm Attendant Level 1 (as defined).

Under 17 years of age	65%	216.50
Over 17 years of age but under 18 years of age	75%	249.80"

2. Delete from subclause (b) of Clause 14 - FIRST AID, the amount of "\$1.75" appearing therein and insert in lieu thereof "\$1.80".
