THE FERRO ALLOYS AWARD IS VARIED AS FOLLOWS:

Delete Clause 6 - Parties and Persons Bound, and insert in lieu thereof the following:

"CLAUSE 6 - PARTIES AND PERSONS BOUND

Unless otherwise specified, this award shall have application to and be binding upon:

- (i) the Tasmanian Electro Metallurgical Company Pty Ltd (hereinafter called TEMCO);
and
- (ii) all employees of TEMCO engaged in the classification and grades set out in this award;
- (iii) the following organisations of employees in respect of whom award interest has been determined:
 - (A) the Automotive, Food, Metals, Engineering, Printing and Kindred Industries Union;
 - (B) The AWU-FIME Amalgamated Union, Tasmania Branch;
 - (C) the Construction Forestry Mining and Energy Union, Tasmanian Branch;
 - (D) the Communications, Electrical, Electronic, Energy, Information, Postal, Plumbing and Allied Services Union of Australia;
 - (E) the Transport Workers' Union of Australia, Tasmanian Branch.
