Appendix 1

3. APPLICATION

This Agreement is made between the Minister Administering the State Service Act 2000, the Australian Nursing and Midwifery Federation (Tasmanian Branch) and applies to nursing and midwifery employees employed under the Nurses and Midwives (Tasmanian State Service) Award.

4. RELATIONSHIP TO THE AWARD

Where any inconsistency occurs between this Agreement and the Nurses and Midwives (Tasmanian State Service) Award, the Nurses and Midwives [Tasmanian State Service] Interim Agreement 2013 or the Nurses and Midwives [Tasmanian State Service] Agreement 2014, this Agreement shall prevail to the extent of any inconsistency.

5. DATE AND PERIOD OF OPERATION

This Agreement has effect from the date of registration and will remain in force until the 30 November 2016.

6. WORK VALUE REVIEW

This Agreement settles the work value review of nursing classification grades 5, 6, 7, 8 and 9 as prescribed by:

(a) Clause 5.2.12 of the Nurses and Midwives Heads of Agreement 2010, which is

- (b) Clause 19 of the Nurses and Midwives [Tasmanian State Service] Interim Agreement 2013; and
- (c) nursing classification grades 6, 7, 8 and 9 as prescribed by Clause 15 of the Nurses and Midwives [Tasmanian State Service] Agreement 2014.

7. WORK VALUE & GENERAL SALARY INCREASES

- (a) The total of the salary increases due to the work value review are:
 - o \$870 pay rise for G6Y1;
 - o \$890 pay rise for G6Y2;
 - o \$910 pay rise for G6Y3;
 - o \$2800 pay rise for G7AY1 and G7AY2;
 - o \$2684 pay rise for G7BY1;
 - o \$3343 pay rise for G7BY2;
 - o \$4000 pay rise for G7BY3;
 - o \$2967 pay rise for G8L2,
 - o \$2417 pay rise for G8L3; and
 - o \$1871 pay rise for G8L4.
- (b) The total increase payable according to sub-clause (a) is paid in two instalments from the first full pay period on or after (ffppooa) 1 July 2015 and the ffppooa 1 July 2016, subject to the processes specified in sub-clauses (c) and (d) of this clause.
- (c) The first work value salary instalment payable from the ffppooa 1 July 2015 is to be;
 - (i) one half of the total salary increases specified in sub-clause (a) of this clause; and
 - (ii) this amount is added to each of the salary points specified in sub-clause (a) of this clause; and
 - (iii) this new salary is to be increased by 2% from the ffppooa 1 December 2015, consistent with Clause 10.1 of the Nurses and Midwives [Tasmanian State Service] Agreement 2014.
- (d) The second work value salary instalment payable from the ffppooa 1 July 2016 is to be;
 - (i) one half of the total salary increase outlined in sub-clause (a) of this clause; and
 - (ii) this amount is to be increased by 2% at that time; and
 - (iii) this compounded salary increase is then added to the salary that is payable from the ffppooa 1 December 2015.

- (e) A new salary progression point is introduced at:
 - the top of G6 (G6Y4); and
 - is (re)introduced at the bottom of G7a (G7aY0).
- (f) The salary progression point of G6Y4 is accessible from:
 - the normal anniversary date of the employee's appointment to that classification grade 6, if the employee has received a salary increment within 12 months of the date of registration of this Agreement; or
 - for employees who have been at the top salary progression point for 12 months or more, progress to G6Y4 is from 1 July 2015.
- (g) The new salary point of G7aY0 is the introductory pay point for new appointments to G7a following the date of registration of this Agreement. This salary point reintroduces the salary point that was removed according to Clause 10 of the Nurses and Midwives [Tasmanian State Service] Agreement 2014.
- (h) Employees classified at G8 Level 1 are, for the life of this Agreement, paid at the same pay point and salary increases as employees classified and paid at G7b Y3, which was renamed from G7bY4 in Appendix A of the Nurses and Midwives [Tasmanian State Service] Agreement 2014 due to the removal of overlapping pay points.

8. REVIEW OF AWARD AND AGREEMENTS

- (a) The parties to this Agreement commit to a review of the Nurses and Midwives (Tasmanian State Service) Award, the Nurses and Midwives [Tasmanian State Service] Interim Agreement 2013, the Nurses and Midwives [Tasmanian State Service] Agreement 2014 and this Agreement by November 2016.
- (b) The purpose is to consolidate and modernise the Nurses and Midwives (Tasmanian State Service) Award by incorporating all the relevant provisions that prescribe the terms and conditions of employment of nurses and midwives from the Nurses and Midwives [Tasmanian State Service] Interim Agreement 2013, the Nurses and Midwives [Tasmanian State Service] Agreement 2014 and this Agreement.
- (c) The provisions that are agreed by the parties that do not relate to terms and conditions of employment, or that are of an indeterminate or interim nature are to be retained in an industrial agreement that is registered under section 55 of the Industrial Relations Act 1984.

(d) The process to undertake the review is through a Joint Working Group established by the parties to commence work by the end of February 2016.

9. TABLE OF SALARY CHANGES

This Table of Salary Changes specifies the work value salary instalments, general salary increases and the timing of these adjustments at the relevant salary points, as prescribed by this Agreement.

- (c) Column 2 'Removal of Overlapping Pay Points + Work Value Salary Increase First Instalment ffppooa 1 July 2015' specifies the salaries that are payable from the ffppoa 1 July 2015 according to Clause 7(c)(i) and (ii), (e), (g) and (h) of this Agreement and clause 10.2 of the Nurses and Midwives [Tasmanian State Service] Agreement 2014.
- (d) Column 3 '2% Salary Increase ffppooa 1 December 2015' specifies the salaries that are payable from the ffppoa 1 December 2015, according to Clause 10.1 of Nurses and Midwives [Tasmanian State Service] Agreement 2014 and Clause 7(c) (iii) of this Agreement.
- (e) Column 4 'Work Value Salary Increase Second Instalment ffppooa 1 July 2016' specifies the salaries that are payable from the ffppoa 1 July 2016, according to Clause 10.1 of Nurses and Midwives [Tasmanian State Service] Agreement 2014 and Clause 7(d) of this Agreement.
