VARIATION OF THE POLICE AWARD [2023] TASIC 68

AMENDED DECISION

REASONS FOR DECISION

HOBART, 12 DECEMBER 2023

[1] On 28 November 2023, the Police Association of Tasmania (PAT) lodged with the Registrar, pursuant to section 23 of the *Industrial Relations Act 1984* (the Act), an application to vary the Police Award.

[2] The variations relate to various specialist allowances and are best described by setting out the table appearing in the Applicants submissions as follows:

[3] In addition, team leaders in the Special Operations Group and Inspectors (in certain circumstances) receive allowances as do dog handlers. The increases are in line with increases in the relevant CPI index and are appropriate.

[4] I am satisfied that the application is consistent with the public interest requirements of the Act and does not disadvantage the Award-covered employees. I am satisfied that the variation should be approved.

[5] The application for variation is granted with an operative date of 2 November 2023.
