ORDER BY CONSENT :

AMEND THE SHIPBUILDERS AWARD, PART II - CONDITIONS, IN THE FOLLOWING
MANNER:

1. Section I - Clause 1 - Special Rates - by amending as follows:
 - (a) Delete "28 cents" and insert "29 cents".
 - (b) Delete "35 cents" and insert "36 cents".
 - (c) (i) Delete "28 cents" and insert "29 cents".
(ii) Delete "73 cents" and insert "76 cents".
 - (d) Delete "28 cents" and insert "29 cents".
 - (e) Delete "25 cents" and insert "26 cents".
2. Section I - Clause 7 - by deleting the amount "\$4.50" appearing in sub-clause (d) and inserting in lieu thereof "\$4.70".
3. Section I - Clause 11 - Travelling Time - by deleting the amount "26 cents" appearing in sub-clause (b) and inserting in lieu thereof "27 cents".
4. Section I - Clause 12 - Distant Jobs - by deleting the amount "\$2.60" and inserting in lieu thereof "\$2.70".

5. Section II - Clause 2 - Special Rates - by amending as follows:
- (a) Delete "28 cents" and insert "29 cents".
 - (b) Delete "35 cents" and insert "36 cents".
 - (c) (i) Delete "28 cents" and insert "29 cents".
(ii) Delete "73 cents" and insert "76 cents".
 - (d) Delete "28 cents" and insert "29 cents".
 - (e) Delete "25 cents" and insert "26 cents".
6. Section II - Clause 3 - Disability Allowance - by deleting the amount "\$12.20" and inserting in lieu thereof "\$12.70".
7. Section II - Clause 8 - Overtime - by deleting the amount "\$4.50" and inserting in lieu thereof "\$4.70".
8. Section II - Clause 14 - Tools - by deleting the amount "\$10.40" and inserting in lieu thereof "\$10.80".
9. Section II - Clause 15 - Travelling Time - by deleting the amount "26 cents" appearing in sub-clause (b) and inserting in lieu thereof "27 cents".
10. Section II - Clause 16 - Distant Jobs - by deleting the amount "\$2.70" and inserting in lieu thereof "\$2.80".

The foregoing variations shall have effect from the first pay period commencing on or after 4 November 1985.

Provided that, it is a term of this award that the unions undertake that they will not pursue any extra claims, award or overaward, except where consistent with the Principles of Wage Fixation of the Tasmanian Industrial Commission.
