ORDER -

AMEND THE **TIMBER MERCHANTS AWARD** IN THE FOLLOWING MANNER:

AMEND THE **TIMBER MERCHANTS AWARD** BY DELETING CLAUSE 6. - PARTIES AND PERSONS BOUND - AND INSERTING IN LIEU THEREOF THE FOLLOWING:

"6. PARTIES AND PERSONS BOUND

Unless otherwise specified, this award shall have application to and be binding upon:

- (a) all employers (whether members of a Registered Organisation or not) who are engaged in the industry specified in Clause 2 - Scope;
- (b) all employees (whether members of a Registered Organisation or not) for whom classifications appear in this award and who are engaged in the industry specified in Clause 2 - Scope;
- (c) the following organisations of employees in respect of whom award interest has been determined:-
 - (i) the Amalgamated Society of Carpenters and Joiners of Australia, Tasmanian Branch, and the officers of that organisation and their members who are employed in the industry specified in Clause 2 - Scope;
 - (ii) the Australian Timber Workers' Union, Tasmania Branch and the officers of that organisation and their members who are employed in the industry specified in Clause 2 - Scope;
 - (iii) the Federated Clerks' Union of Australia, Tasmanian Branch and the officers of that organisation and their members who are employed in the industry specified in Clause 2 - Scope;
 - (iv) the Shop Distributive and Allied Employees' Association, Tasmanian Branch, and the officers of that organisation and their members who are employed in the industry specified in Clause 2 - Scope;
 - (v) the Transport Workers' Union, Tasmanian Branch, and the officers of that organisation and their members who are employed in the industry specified in Clause 2 - Scope; and
 - (vi) the United Sales Representatives and Commercial Travellers' Guild of Australia, Tasmanian Branch and the officers of that organisation and their members who are employed in the industry specified in Clause 2 - Scope;

(d) the following organisations of employers in respect of whom award interest has been determined:-

- (i) the Tasmanian Sawmillers Industrial Association and the officers of that organisation and their members who are engaged in the industry specified in Clause 2 - Scope;
- (ii) the TGFA Industrial Association and the officers of that organisation and their members who are engaged in the industry specified in Clause 2 - Scope; and
- (iii) the Tasmanian Confederation of Industries."

DATE OF OPERATION

The foregoing determinations shall come into operation as follows:

in respect of paragraphs (c) (i), (ii), (iii), (iv), (v) and (vi) above - from 10 April 1989;

in respect of paragraphs (d) (i), (ii) and (iii) above - from 30 May 1989.
