IN THE MATTER OF an application by the Tasmanian Trades and Labor Council to increase salaries and allowances in the AWARD OF THE SHIPBUILDERS INDUSTRIAL BOARD in accordance with the National Wage Case decision of 3 April 1985

ORDER BY CONSENT -

The above award is varied as follows:

PART II - CONDITIONS

1. By deleting the title of the award and inserting in lieu thereof "Shipbuilders Award".
2. Section I - Clause 1 - Special Rates - by amending as follows:
  - (a) Delete "27 cents" and insert "28 cents".
  - (b) Delete "34 cents" and insert "35 cents".
  - (c)(i) Delete "27 cents" and insert "28 cents".
  - (ii) Delete "71 cents" and insert "73 cents".
  - (d) Delete "27 cents" and insert "28 cents".
  - (e) Delete "24 cents" and insert "25 cents".
3. Section I - Clause 7 - by deleting the amount "\$4.40" appearing in sub-clause (d) and inserting in lieu thereof "\$4.50".
4. Section I - Clause 11 - Travelling Time - by deleting the amount "25 cents" appearing in sub-clause (b) and inserting in lieu thereof "26 cents".

5. Section I - Clause 12 - Distant Jobs - by deleting the amount "\$2.50" and inserting in lieu thereof "\$2.60".
6. Section II - Clause 2 - Special Rates - by amending as follows:
  - (a) Delete "27 cents" and insert "28 cents".
  - (b) Delete "34 cents" and insert "35 cents".
  - (c)(i) Delete "27 cents" and insert "28 cents".
  - (ii) Delete "71 cents" and insert "73 cents".
  - (d) Delete "27 cents" and insert "28 cents".
  - (e) Delete "24 cents" and insert "25 cents".
7. Section II - Clause 3 - Disability Allowance - by deleting the amount "\$11.90" and inserting in lieu thereof "\$12.20".
8. Section II - Clause 8 - Overtime - by deleting the amount "\$4.40" and inserting in lieu thereof "\$4.50".
9. Section II - Clause 14 - Tools - by deleting the amount "\$10.10" and inserting in lieu thereof "\$10.40".
10. Section II - Clause 15 - Travelling Time - by deleting the amount "25 cents" appearing in sub-clause (b) and inserting in lieu thereof "26 cents".
11. Section II - Clause 16 - Distant Jobs - by deleting the amount "\$2.60" and inserting in lieu thereof "\$2.70".

The foregoing variations shall have effect from the first pay period commencing on or after 6 April 1985.
