**2. Insert a new Clause 32A as follows:**

**"32A.RELATIONSHIP TO THE NATIONAL TRAINING WAGE (TASMANIAN PRIVATE SECTOR) AWARD"**

A party to this award shall comply with the terms of the National Training Wage (Tasmanian Private Sector) Award, as varied, as though bound by Clause 6 of that award."

The foregoing variations shall come into effect from the first full pay period commencing on or after 16 June 1995.
