COMMISSIONER WATLING: You will get more appearance money than some of these footballers.

MR T.J. EDWARDS: If it please the commission, EDWARDS, T.J. I appear for the TCI and MIAT.

COMMISSIONER WATLING: Good. Thank you. Mr Baker.

MR BAKER: Sir, I would seek that these proceedings be adjourned into a conference under your chairmanship.
