6. PARTIES AND PERSONS BOUND

- (c) the following organisations of employees in respect of whom award interest has been determined:
 - (i) the Amalgamated Society of Carpenters and Joiners of Australia, Tasmania Branch and the officers of that organisation and their members employed in the industry specified in Clause 2 - Scope;
 - (ii) the Australian Workers' Union, Tasmanian Branch and the officers of that organisation and their members who are employed in the industry specified in Clause 2 - Scope;

- (iii) the Building Workers' Industrial Union of Australia, (Tasmanian Branch) and the officers of that organisation and their members who are employed in the industry specified in Clause 2 Scope; and
- (iv) the Electrical Trades Union of Australia, Tasmanian Branch and the officers of that organisation and their members who are employed in the industry specified in Clause 2 Scope;
- (v) Federated Clerks Union of Australia, Tasmanian Branch and the officers of that organisation and their members who are employed in the industry specified in Clause 2 - Scope;
- (vi) the Federated Engine Drivers' and Firemen's Association of Australasia, Tasmanian Branch and the officers of that organisation and their members who are employed in the industry specified in Clause 2 - Scope; and
- (vii) the Metals and Engineering Workers' Union and the officers of that organisation and their members who are employed in the industry specified in Clause 2 - Scope;
- (viii) the Transport Workers' Union of Australia, Tasmanian Branch and the officers of that organisation and their members who are employed in the industry specified in Clause 2 Scope.
- (d) the following organisation of employers in respect of whom award interest has been determined:

 - (v) the Electrical Trades Union of Australia, Tasmanian Branch and the officers of that organisation and their members who are employed in the industry specified in Clause 2 - Scope;
 - (vi) Federated Clerks Union of Australia, Tasmanian Branch and the officers of that organisation and their members who are employed in the industry specified in Clause 2 - Scope;
 - (vii) the Federated Engine Drivers' and Firemen's Association of Australasia, Tasmanian Branch and the officers of that organisation and their members who are employed in :the industry specified in Clause 2 - Scope; and
 - (viii) the Transport Workers' Union of Australia, Tasmanian Branch and the officers of that organisation and their members who are employed in the industry specified in Clause 2 Scope.
