AMEND THE **CEMENT MAKERS AWARD** IN THE FOLLOWING MANNER:

AMEND THE **CEMENT MAKERS AWARD** BY DELETING CLAUSE 6 - PARTIES AND PERSONS BOUND AND INSERTING IN LIEU THEREOF THE FOLLOWING:

"6. PARTIES AND PERSONS BOUND

Unless otherwise specified, this award shall have application to and be binding upon:

- (a) all employers (whether members of a Registered Organisation or not) who are engaged in the industry specified in Clause 2 - Scope;
- (b) all employees (whether members of a Registered Organisation or not) for whom classifications appear in this award and who are engaged in the industry specified in Clause 2 - Scope;
- (c) the following organisations of employees in respect of whom award interest has been determined:
 - (i) the Amalgamated Metal Workers' Union and the officers of that organisation and their members who are employed in the industry specified in Clause 2 - Scope;
 - (ii) the Amalgamated Society of Carpenters and Joiners of Australia, Tasmania Branch and the officers of that organisation and their members employed in the industry specified in Clause 2 - Scope;
 - (iii) the Australian Workers' Union, Tasmanian Branch and the officers of that organisation and their members who are employed in the industry specified in Clause 2 - Scope;
 - (iv) the Building Workers' Industrial Union of Australia, (Tasmanian Branch) and the officers of that organisation and their members who are employed in the industry specified in Clause 2 - Scope; and
 - (v) the Electrical Trades Union of Australia, Tasmanian Branch and the officers of that organisation and their members who are employed in the industry specified in Clause 2 - Scope;
 - (vi) Federated Clerks Union of Australia, Tasmanian Branch and the officers of that organisation and their members who are employed in the industry specified in Clause 2 - Scope;
 - (vii) the Federated Engine Drivers' and Firemen's Association of Australasia, Tasmanian Branch and the officers of that organisation and their members who are employed in :the industry specified in Clause 2 - Scope; and
 - (viii) the Transport Workers' Union of Australia, Tasmanian Branch and the officers of that organisation and their members who are employed in the industry specified in Clause 2 - Scope.
